Schools to Approve

- City Colleges of Chicago
 - ECE
 - All competencies met
 - Required experience hours are embedded into the coursework
 - Assessment titles need to be more descriptive
 - 109 & 143 need to be removed from the Program Layout
 - 262 needs to be added to the level 3 Program Layout
 - 210 needs to be added to the Program layout and a syllabus is needed
 - ITC
 - All competencies have been met
 - Required experience hours are embedded into the coursework
 - Assessment titles need to be more descriptive
 - DC 259 shows 250 hours
 - Listed on both ECE and ITC Program Layout
 - Needs a clear breakdown of age ranges
 - CD 248, 107 and 259 are missing from the Program Layout
 - IDC
 - All competencies met

- Some level 2 competencies addressed
 - Recommend they be removed
 - Students applying will need 1200 hours of administrative work experience
 - Higher Education Liaison will follow up with faculty regarding suggested edits
 - Lewis and Clark
 - ECE
 - All competencies met
 - Required experience hours are embedded into the coursework
 - ITC
 - All competencies met
 - Required experience hours are embedded into the coursework
 - Only applying for ITC Level 2
 - IDC
 - All competencies met
 - Required ECE experience hours are embedded into the coursework
 - Students will be required to obtain 1200 hours of documented administrative hours
 - Entitled Review Group voted and approved Lewis and Clark for ECE 4, ITC 2, and IDC 1
 - Illinois Valley Community College
 - Need correct syllabi
 - Higher Education Liaison will contact faculty
 - Application will be reviewed at March meeting

Schools to Approve

- Highland Community College
 - ECE:
 - PPD4 (level 3) – ECE 212 is missing from PL
 - Recommend it to be assessed in ECE 203
 - Program Layouts:
 - Level 2 – Remove ECE 125 and ECE 202, no competencies assessed (Could keep 125 because of observation hours)
 - Level 3 – ECE 128 Practicum hours are the same as on the ITC PL
 - ECE 212 is missing but is assessed in PPD4
 - Update total experience hours to reflect 10 OR 74
 - Level 4 – Combine ECE 125 and ECE 2014 into one box like on the Level 3 PL
 - ECE 209 Internship – no competencies

- Recommend at least one competency is assessed
 - Update to 125 hours so the remaining 100 hours can be used for the IDC ECE experience hours
 - Update total experience hours to reflect 135 OR 189
 - ITC:
 - ECE 128 Practicum has no IT competencies
 - The 64 hours are also included in ECE PL
 - Recommend increasing work experience in ECE 205 and 213 to 25 hours each or the equivalent of 50 hours total
 - OR students would have to supplement the remaining 60% (540 hours of documented work experience)
 - IDC:
 - ECE 209 ECE Internship – no IDC competencies assessed
 - Update to 100 hours (remaining 125 is used for ECE Level 4)
 - Move it to bottom of the PL into the total hours box instead of listed with Admin courses
 - Recommend at least one or more IDC competencies assessed in ECE 211 Management Practicum
 - ECE/ITC/IDC approved pending updates
 - Higher Education Liaison will follow up with faculty regarded suggested edits
- Waubonsee
 - ECE
 - All competencies met
 - Practicum is used for more than one credential, which could be confused as double the embedded hours
 - Age-range of experience hours needs to be more clear
 - ITC
 - All competencies met
 - ITC4
 - Need to remove 198 from the PL, as well as 220, 140, 210, and 215
 - IT-specific experience hours should be changed to 140 or 120
 - ITC3
 - Need to remove 198 from the PL
 - Age range of embedded hours needs to be clear
 - ITC2
 - 204 should be removed from the competency Alignment Table
 - IDC
 - All competencies assessed
 - Required hours are embedded in coursework
 - 101, 115, 198, 106, 120, 125, 130, 220, 140, 210, 215 can be removed from the Program Layout as they do not satisfy competencies
 - Eng 101 is used to satisfy T1 competency and should be added to Program layout
 - Higher Education Liaison will follow up with faculty regarding the suggested edits
